OUR FIVE BASIC POINTS

1°. Minimum retirement not less than the Basic Basket of the Elderly calculated by the Ombudsman for the Third Age of CABA.

2°. 82% mobile on the salary of the active worker in the same position, trade or function and the recomposition according to the work history of each worker with recomposition of all scales.

3°. Creation of the National Institute of Social Welfare, which will function as a non-profit, non-state public law entity, with self-sufficiency and legal, financial, accounting and administrative economic autonomy, directed and managed, as established by the National Constitution, by its stakeholders, which are the representatives of active workers, retirees and the participation of the State.

4°. Normalization of the INSSJP (PAMI), putting an end to the Intervention and updating all those concepts corresponding to social benefits, guaranteeing equitable, effective and timely coverage of the beneficiaries, whatever their place of residence.

5°. Housing in Comodato for retirees and pensioners, 10 (ten) percent of the housing units whose construction is financed directly or indirectly, totally or partially, with funds from the National Treasury.

Without unions, without parity, without the possibility of carrying out forceful measures that affect the productive apparatus, the retired and pensioned sector has been subjected to a constant deterioration of its economic situation for decades.

In recent years, the trend of wanting to counteract this deterioration through the sporadic granting of bonuses that are not added to the credit and that do not obey any other logic than that of "throwing a bone" to retirees every time the situation has become chronic. due to the rise in inflation, it becomes too evident.

Every time a bonus is announced, a back-and-forth media and political mechanism is put into operation with respect to its usefulness. Does it work or does it not work? Does it really impact the objective situation of those who receive it? Is it little? Should it be more? All questions and discussions that do not affect the underlying issue.

What good is a one-time \$12,000 bonus to someone who is almost \$70,000 short of what they would need to have a decent life? And if in four months they grant you another similar bonus, does anything change in your objective situation?

Dr. Eugenio Semino - Ombudsman for the Elderly - President The answers to these questions are obvious. Discussing bonuses is a waste of time that helps mask the real problem, which is the credit itself. What needs to be discussed is the reconstitution of that asset. A reconstitution that not only has to be carried out in the name of the retired men and women of today but also of those of tomorrow. For this reconstitution to be possible, it is necessary to establish a parameter, even if it is not initially a long-term objective. In this sense, we propose that the Basic Basket of Retirees be taken as a reference to establish a floor for the amount of the minimum retirement, currently the Basic Basket triples the minimum retirement. And that the entire scale of retirements, including the minimum ones, be adjusted following the three highest parities of the year.

> It should be a commitment of all present and future government administrations to agree on the means to reasonably achieve said objective, making gradual increases in credit that are integrated into it and that allow the retiree to recover real purchasing power against inflation. Retired men and women add up to almost seven million people, something like 12% of the total population of the country. The general economic situation is not resolved, neither on the left nor on the right, if the reality of the sector is not addressed.

CHACO SUBSIDIARY

In our province, 80% of retirees receive the minimum amount.

Due to this, there is a lot of concern about the payment of the bonus to PAMI general practitioners and medical specialists.

Our subsidiary held three meetings with the PAMI Directorate, to deal especially with this issue. In September 2021, a regulation was made on this subject in the PAMI, which was publicly announced in March of this year by the Presidency and by the Comptroller of the Institution, but it is not fulfilled in its entirety.

Together with the Public Transport Retiree Center and the National Retiree Center, we held three meetings with 5 Retiree Centers, with the participation of some 50 people with an excellent debate.

We also held four meetings with the Medical College, provider of the PAMI, to discuss these issues and we added Health and geriatrics, agreeing to create a space in the College between professionals and members of the Retirement Centers, which is in the process of being formed. of the Province, where lack of protection is complex.

We normally hold these meetings with the participation of three Retiree Centers and the Board.

For some time now, we have achieved a Retiree Space, from 11 a.m. to 11:50 a.m. on Radio Independencia, which has been operating normally since February of this year. We also have, once a week, a report on Radio Natagala, which is connected with Resistance Channel 2. In this way, since March we go out on the radio and at 8:00 p.m. they broadcast the interview on the Channel.



MOI RETIRED CENTER

On Monday, May 2, we carried out two important activities, with other organizations, to present in Congress, for the

third time, the National Law Project for Self-Managed Social Production of Habitat Popular Self-management, which is the way in which cooperatives that belong to various organizations such as the Moi or the Territorial Liberation Movement build homes for their associates through a system where the resources that the state allocates to housing cooperatives are self-managed without a housing company. through what we call "Mutual Aid", where the members of the same allocate an agreed time in the construction of their homes. In addition, work cooperatives belonging to the organizations are formed. This results in that, on the one hand, costs are considerably lowered and workers can be paid above the agreements established by the unions. This law that we are promoting at the national level is so that throughout the country it can be replicated what in Caba is Law 341, of which the Moi together with other organizations were decisive actors in its implementation and which contemplates not only the credit to build but also the adjudication of the land. In short, self-management is a system of social and economic organization where associates internally manage resources and make decisions through democratic consensus.

RETIRED TEACHERS: NO INCREASE IN THE MONTH OF JUNE

In 2005, the CTERA announced with great fanfare that we repealed by the regulatory decree, which is questionable) retired teachers had recovered 82%, after discounting another 2% for pension contributions, which went from 11 to 13%. But since the bureaucracy usually tells the half-truth, they omitted to say that that 82% was the salary at termination and that retirement would not be automatically adjusted when active teachers received a raise. For increases, the RIPDOC (Average Teacher Taxable Remuneration) is applied twice a year, in March and September, according to what was collected by ANSES in the previous semester. It should be noted that this calculation is a taboo, the aforementioned institution does it according to figures that it into account the educational decentralization carried out manages and that nobody controls.

It was to be expected that in a context of higher increases, in June/2022 it would take the same measure, but it was not. So far this year we only had a 9.38% increase while inflation is around 30%. In other words, we have already lost 20 points and we still have to wait until September. ANSES interprets that the increase by RIPDOC does not correspond to them and argues that it does not have the information of the eleven provinces that transferred their boxes to make the readjustments effective. Given this, the solution is to carry out an administrative procedure, which consists of requesting the updating of the credit in their respective jurisdictions and which takes at least one year.

To understand how this labyrinth came about, which of course is to the detriment of the workers, we must take with the State's bilge policies, which broke the unity of In December 2021, the government gave us an advance of teaching. The slogan raised in the 1970s: "equal pay for equal work" gradually faded away as educational systems moved to the provinces. It is worth paraphrasing the old adage: divide and adjust, proof of this are the retrograde reforms that were applied in the province of Córdoba in 2020, in the midst of a pandemic and that went almost unnoticed.

We should not passively endure this situation. From the

through the stage of the pandemic with ups and downs. In March 2020, we canceled specialized gym classes for older adults, cultural activities, and gateball matches, a Japanese game similar to cricket, at the sports center. We slowly started to test the intercommunication by digital means. Retirees from the Center from other countries also participated in the talks and conferences of general interest via zoom. From Japan, through JICA, a government body for international cultural cooperation in that country, we received information to access subsidies for community entities for the prevention of Covid, health care instructions, games and digital recreational materials in Japanese and Spanish that we forwarded to everyone who had an email. For people who did not have access to the internet, we organized a chain of calls to the landline to keep in touch. Even so, the pandemic was difficult to overcome and there were consequences, especially in munity. mental health. There are people who, despite being vaccinated, are reluctant to leave their homes.

At the Japanese Association Retirement Center we went At the end of 2021 we started some face-to-face meetings outdoors in the Association's sports center and we inaugurated La Casita de los Jubilados in March 2022. It is a deposit that was recovered and refurbished within the property that has four hectares. Several members of the Center proposed to make an organic garden because we have enough land available. It is a proposal that is under study due to the characteristics of the soil.

> At the headquarters we started some activities sporadically.

option to another year for men. If approved, some 120,000 women would be eligible for retirement in the second half of the year, who are surely counting down the days to obtain it. We all know the reasons why measures of this type are essential and hence our support. Starting in the 1990s, with the Menem government, industries and state-owned companies were pulverized, leaving the hitherto economically active population without work and, therefore, without contributions to social security. As a result of this paradigm shift in the capitalist system, we find that currently 60% of people who are ten years or less from retirement age do not make pension contributions. We know that this measure is transitory until a new law is enacted and it is essential that, together with the law, its

financing be voted on, since it is the State, through its governments, that is responsible for the illegality of unregistered, precarious, unemployment, underemployment, defunding of the pension system, otherwise only misery will be distributed. It is essential to give legal coverage to the millions of workers that the system excluded and excludes, but the assets must allow a decent life. Otherwise, a broad coverage only leads to a subsidy for old age, which is the objective of the agreements with the IMF, at the service of the large dominant economic groups, for the payment of the illegitimate, fraudulent, odious external debt, and that it is not justice.


